## PSM's June Webinar Series: Human Trafficking

### Child Sex Trafficking in Maryland

Most people believe that sex trafficking happens in Cambodia, Thailand and the countries on the other side of the world. The truth is that sex trafficking happens in the United States including communities throughout Maryland as well.

Since 2000, with the passage of the Trafficking Victims Protection Act, human trafficking of any kind is illegal on American soil. Human trafficking is a criminal industry with an estimated annual profit of \$150 billion. Most of the victims are used in labor trafficking but the majority of the profits, \$99 billion, are made in the sex trafficking industry.

There have been more than 670 survivors of sex trafficking reported to DSS offices across Maryland since 2014 and the majority of those are Maryland residents between the ages of 14 and 17. (University of Maryland, School of Social Work) In 2019, there were 143 reports made to DSS offices of suspected child sex trafficking cases. The majority of cases are reported in Baltimore City however Washington, Prince George's, Baltimore County, Anne Arundel, Harford, Montgomery, and Frederick counties consistently report cases to DSS offices. Every jurisdiction in Maryland has had reported cases of minor sex trafficking.

Many factors can contribute to the vulnerability of a child to this issue. A disconnection from their family, previous history of sexual abuse, chronically missing youth, an intersection with social services and strong online presence can all be factors that increase a child's risk of trafficking. Traffickers are



keenly aware of how to identify the need of a child and provide that need in order to develop a connection of trust. From there every step of the process is intentionally planned to manipulate the child into increasingly exploitive behaviors.

### Child Sex Trafficking Stat Sheet

- Between June 2013 and May 2020, there were **679** reports of child sex trafficking screened by Maryland DSS CPS Screening Units.
- In 2019, the last full year of reporting, 143 cases were reported to DSS offices around Maryland.
- Although reports have been made in every county across the state, the jurisdictions with the highest number of cases reported include:
  - 1) Baltimore City
  - 2) Washington County
  - 3) Prince George's County
  - 4) Baltimore County
  - 5) Harford County
  - 6) Anne Arundel County
  - 7) Montgomery County
  - 8) Frederick County
  - 9) Charles County
  - 10) Howard County
- Maryland is not currently a Safe Harbor state which means that anyone under 18 can still be charged with prostitution in spite of the federal law that defines them as a victim in any commercial sex act. There have been 102 minors charged with prostitution between 2013-2019; 17 of those were between the ages of 10-14.
- Based on over 26,000 missing child cases at NCMEC involving possible CST between January 2004 and December 31, 2019:
  - 95.1% - Female
  - 4.9% - Male
  - 75% were in Foster Care and Social Services
  - 24% were with biological family members
  - 40.6% - Black
  - 35.2% - White
  - 11.7% - Hispanic
  - 10.2% - Biracial
  - 1.0% - American Indian
- National Human Trafficking Hotline stats
  - Since 2007 – 17,271 Child Sex Trafficking victims have been identified
  - 13,864 Sex trafficking / 1686 Labor trafficking / 914 Sex and Labor trafficking / 807 Not specified
- The average life expectancy of a female being exploited through sex trafficking is 7 years. Homicide and AIDS are the top two causes of death. (FBI)
- Victims of child sex trafficking report they are given typical quotas of 10-15 buyers per night. (Shared Hope International)
